

Disaster Response Resources include materials, funds and personnel.

The personnel available to the community from your United Methodist Church include District Superintendents, their Administrative Assistants and members of the Texas Annual Conference Committee on Relief.

TACCOR coordinates six teams in a diverse approach to response.

- We send Early Response Teams to clean out homes making them safe and secure.
- We have CARE Teams to offer emotional and spiritual support for survivors to cope with their loss.
- We provide direction, referral and guidance in a chaotic environment with Call Center Teams .
- We help move supplies and materials needed to support relief efforts with Logistic Teams.
- We support churches willing to host these response teams so they may be near the work areas.
- We plug in those who are moved by the disaster to help but, did not join any of our teams.

Conference Directors oversee these team efforts while District Coordinators manage the collaboration between the personnel. The DS and Administrative Assistants make sure that no request goes unfulfilled and no survivor lost.
