

Disaster Response Resources include materials, funds and personnel.

The personnel available from your United Methodist Church include District Superintendants, their Administrative Assistants and members of the TACCOR.

TACCOR coordinates six teams in a diverse approach to response.

- We send Early Response Teams to clean out homes making them safe, sanitary and secure.
- We have CARE Teams to offer emotional and spiritual support for survivors to cope with loss.
- We provide referral and guidance in a chaotic environment with our Communications Team .
- We help move supplies and materials needed to support relief efforts with our Logistic Team.
- We support churches willing to host Response Teams so they may be near those in need.
- We plug in those who are moved by the disaster to help but, did not join any of our teams.

Conference Directors oversee these team efforts while District Coordinators manage collaboration between the personnel. The DS and their Administrative Assistants make sure that no request goes unfulfilled and no survivor lost.

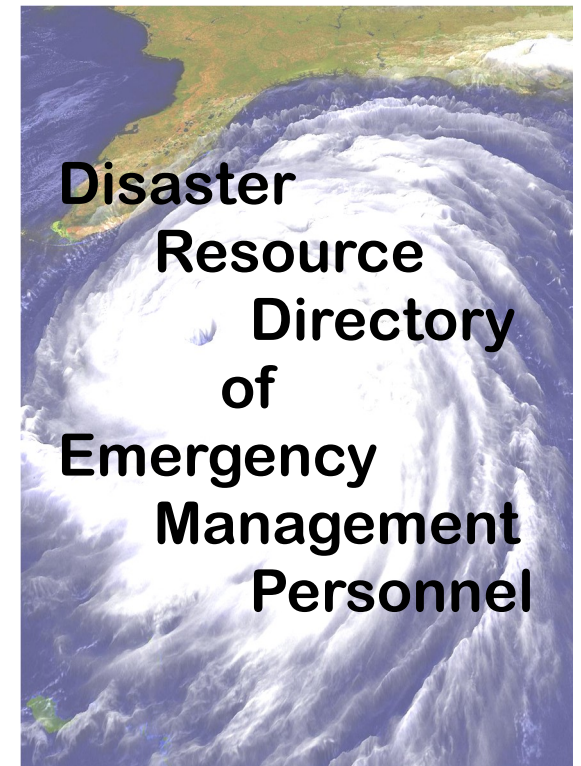
